Mutton Bustin' Sponsorship

Price for this Sponsor Package is \$3500.

The Redding Rodeo will provide the following for the 2016 Mutton Bustin' sponsor.

1. Sponsor's name will be displayed on electronic scoreboard.
2. Special (expanded) recognition by the program announcer.
3. An arena sign (4' x 8') will be posted in the arena, on the gates protecting the Mutton Bustin chute area from the main arena.
4. Sponsor's name and logo will be displayed on the Mutton Bustin' section of the Redding Rodeo Association web site.
5. Display a Sponsor's sign (4' x 8') on the inner side of the gates protecting the Mutton Bustin' chute area from the main arena area. This will allow a Sponsor sign will always be visible to the main grandstand.
6. Sponsor's name and logo will be presented in the Rodeo Souvenir Program Book on the Mutton Bustin page.
7. Sponsor has the right to furnish and distribute additional promotional items to the Mutton Bustin participants, at no charge to the Redding Rodeo Association.
8. Sponsor may designate one (1) staff member or delegate to assist with awarding buckles and other items to participants in the arena concluding each performance.
9. Sponsor shall receive two (2) Rodeo Flats seating area tickets for each nightly performance of Redding Rodeo.
10. 15 General Admission tickets.
(choice of day is at the discretion of Redding Rodeo Association).
(Sponsor may purchase any additional tickets, if desired, at normal retail pricing).

Sponsor acknowledges that this sponsorship is nonexclusive and other sponsors' names, logos or service marks may be displayed on signs, awards including buckles or promotional materials.
